Joanne Banker Hames is an attorney and paralegal educator who has been actively involved in paralegal education since 1977. She is an instructor in and the former coordinator for the ABA-approved paralegal program at DeAnza Community College in Cupertino, California. She earned her J.D. degree from the Santa Clara University School of Law and has been an active member of the California Bar since 1972. As an attorney, she has been involved in research and writing for legal memoranda and appellate briefs. Among the classes she has taught are Ethics, Civil Litigation, Legal Research and Writing, Advanced Legal Research and Writing, and Advanced Legal Research Using LEXIS. She is the co-author of *Civil Litigation, Introduction to Law, Constitutional Law: Principles and Practice* and *Legal Research, Writing and Analysis*.

Mark Hames is an attorney and former prosecutor of thirty years in the Santa Clara County District Attorney’s Office where he was a supervising attorney of the Economic Crimes Group. He also supervised six paralegals within the group and office paralegals in general. He earned his J.D. degree from the Santa Clara University School of Law. He is currently an instructor in the paralegal program at DeAnza Community College where he teaches Legal Research Using the Internet and Microsoft Word for Paralegals. He is also the recipient of a resolution from the California Legislative Assembly for public service during his career.
